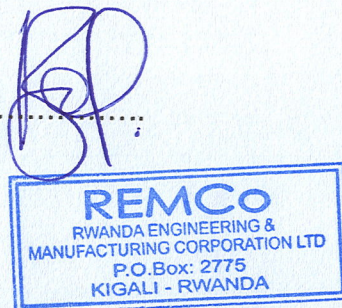

1. Background

REMCO was established to manufacture machines, equipment and spare parts that were previously imported to serve in the sector of Agriculture Mechanization, Construction, Mining, Automotive, Energy, Defence and health care. REMCO also provides technical support services to other local as well as regional companies through training repair and maintenance services.

REMCO would like to procure different types of **Scraps** that will help the factory during its manufacturing activities.

2. Tender presentation

Scraps (High Chromium steel)	carbon 2.6-2.8%, chromium 11.3-17% cr, nickel 0.1-0.3%, manganese 0.3-0.5%, molybdenum 0.04-0.06%, vanadium 0.3-0.5%, titanium 0.005-0.006%, copper 0.7-0.8%, P≤0.03, S≤0.03, surplus are iron.	1
High Manganese scraps	scraps containing at least 11% Mn	2
