# TERMS OF REFERENCE FOR VEHICLE REPAIR AND MAINTENANCE SERVICE

#### SECTION 1. INTRODUCTION AND BACK GROUND

Rwanda Engineering and Manufacturing Corporation (REMCO) is a company that started in 2018 and is owned by the government of Rwanda. REMCO was established to manufacture machines, equipment and spare parts that were previously imported to serve in the sectors of Agriculture mechanization, Construction, Mining, Automotive, Energy, Defense and Health care. REMCO also provides technical support services to other local as well as regional companies through training, repair and maintenance services.

REMCO therefore would like to invite qualified bidders to submit their bids/offers for the tender for provision of vehicle repair and maintenance services (garage).

# **SECTION 2. SCOPE OF SERVICE**

The successful bidder shall be required to provide vehicle repair services including, preventive maintenance like oil changes, tune-ups, fluid checks and others. Mechanical repairs like engine repair, brakes, suspensions, transmissions and others. Electrical system diagnosis and repair. Body work and painting. Supply and replacement of genuine spare parts. Emergency breakdown response. Towing and recovery services as needed. These services will be rendered to the three vehicles owned by REMCO which are TOYOTA HIACE MINIVAN, SUZUKI VITARA and VOLKWAGEN AMAROCK.

The above services shall be offered at the successful bidder's premises and shall be rendered successful upon thorough and clear inspection by the driver or any other appointed member of Remco staff.

# SECTION 3. TENDER PRESENTATION AND REQUIREMENTS

All tenders must include and present the following phases and they will be evaluated in the same fashion.

### 3.1. ADMISTRATIVE ELIGIBILITY

All bidders shall provide the following documents as the first criteria to be followed for the first stage of evaluation.

- a. A valid business registration certificate offered by RDB.
- b. A valid tax clearance certificate offered by RRA.
- c. A valid RSSB certificate offered by RSSB.
- d. A valid VAT certificate offered by RRA.
- e. A sample of EBM invoice.
- f. Three references if similar work done from at least three current or past clients.
- g. A valid and up to date company profile.

# 3.2. TECHNICAL QUALIFICATION AND INSTRUCTIONS

All bidders shall present the following as the second criteria to be followed in the second stage of evaluation.

- a. A list of at least three qualified technicians and mechanics including their certifications or CV's.
- b. A list of standard tools, equipment and machines available and being used at your facility.

### 3.3. FINANCIAL PROPOSAL
