- c. The language to be used as the medium of communication in all the offers shall be in English.
- d. This tender shall only be valid for Seven (7) days.

SECTION 5. OTHER TERMS AND CONDITIONS

- a. REMCO reserves the right to visit any bidder's location/premises during tender evaluation.
- b. All bids shall be opened and evaluated in the absentia of all bidders.

- d. The payment terms shall be 100% payment by cheque or bank transfer upon agreed terms
