## TERMS OF REFERENCE FOR WORKSTATION PC

### SECTION 1. INTRODUCTION AND BACK GROUND

All bidders shall provide the following documents as the first criteria to be followed for the first stage of evaluation.


- a. A valid business registration certificate

- c. The language to be used as the medium of communication in all the offers shall be in English.
- d. This tender shall only be valid for Seven days (7) days.
