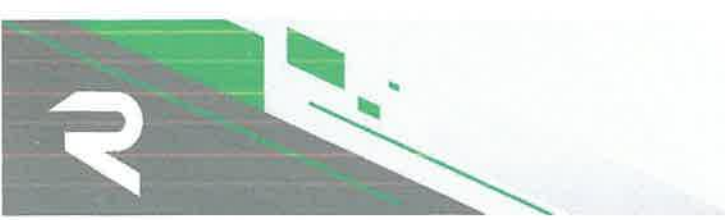

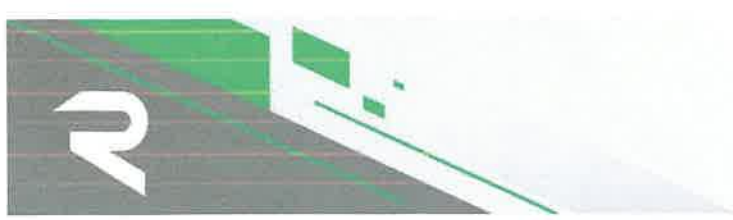

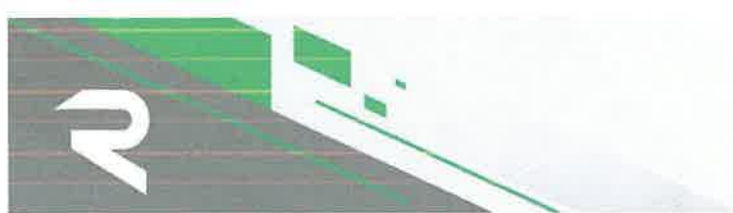

1. Back ground
